IT IS THE INTENTION OF THE UNDERSIGNED PARENT OR GUARDIAN BY THIS AGREEMENT TO EXEMPT AND RELIEVE GRACE COMMUNITY CHURCH AND KIDS INC. AND THEIR OFFICERS, AGENTS, VOLUNTEERS, OR EMPLOYEES FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE, OR WRONGFUL DEATH OF

For and in consideration of permitting my child to observe, or use any facility or equipment or engage in and/or receive instruction in any activity or activity incidental thereto **SOME OF WHICH MAY INVOLVE DANGERS AND RISK OF BODILY INJURY AT: Sports Camp in the city of Dallas, County of Polk, and State of Oregon, beginning on the day of Monday, March 22, 2010,** the undersigned parent and/or guardian **hereby voluntarily and absolutely releases, discharges, waives, and relinquishes any and all loss or damages or actions or causes of action for personal injury, property damage, or wrongful death occurring to my child as a result of my child's observing or using facilities or equipment or engaging in or receiving instructions in any activities SOME OF WHICH MAY INVOLVE DANGERS AND RISK OF BODILY INJURY or in activities incidental thereto wherever or however the same may occur, and for whatever period said activities or instructions may continue.**

The undersigned parent or guardian for him/herself, his/her heirs, executors, administrators, or assigns agrees that in the event any claim for personal injury, property damage, or wrongful death shall be prosecuted against Grace Community Church and Kids Inc. or their officers, agents, volunteers, or employees, the undersigned parent or guardian **will indemnify and hold harmless Grace Community Church and Kids Inc. and their officers, agents, volunteers, or employees** from any and all claims or causes of action by my child or by any other person or entity, by whomever or wherever made or presented, and **under no circumstances will the undersigned parent or guardian present any claim against Grace Community Church and Kids Inc. and said persons for personal injuries, property damage, wrongful death, or otherwise, caused by any act of negligence by Grace Community Church or Kids Inc. and said persons.**

**The undersigned parent or guardian represent that he/she has read the Release,** and requested and has been provided with, or has requested and declined advisement on the potential dangers/risks of engaging in the observation, activities, or instruction offered, **assumes all risks associated with such dangers and risks,** and is fully aware of and understands the terms and the legal consequences of the signing of the Release. The undersigned parent or legal guardian intends his or her signature to be a complete and unconditional release of all liability to the greatest extent allowed by law and if any portion of the Release is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
